## **PUBLIC LAW 111-76**

Amended: 11 March 2018

### TREASON, SEDITION AND SUBVERSIVE ACTIVITIES

Pursuant to the United States of America Republic Constitution Amendment 19, Section 2, Clause 2, wherein it states; "The United States of America Republic shall make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the United States of America Republic, or any Department or Officer thereof", there shall hereby be designated "Treason, Sedition and Subversive Activities" provisions to serve this purpose. This amendment shall go into immediate force.

Introduced as **Senate Joint Resolution 75**, with **66** co-sponsors and as **House Joint Resolution 75** with **66** co-sponsors, a request was delivered before the Continental Congress to honor and therefore establish laws for our Treason, Sedition and Subversive Activities.

The resolution suffered no amendments, no exclusions, no demands that it became law.

The 1st Continental Congress of the United States of America Republic publicly declared 2015 the national "Year of the United States of America Republic". The document known as Public Law PUBLIC LAW 111-76 was signed and enacted into law on 11 March 2018 by the following SIGNATORIES to this Legislative Act in Attendance;

#### **JOINT RESOLUTION**

#### **Authorizing and requesting the President**

to proclaim and establish provisions in accordance with the Constitution and Laws of the United States of America Republic.

**WHEREAS**, the United States of America Republic, being a perpetual corporation is an autonomous State government lawfully incorporated and chartered for the benefit and protection of "We The Moorish American People", by its Declaration, National Constitution and By-Laws, and aforementioned Articles:

**WHEREAS** the United States of America Republic's official language is the English language;

**WHEREAS** the Moorish American People have made a unique contribution in shaping the United States of America Republic as a distinctive and blessed nation of people and citizens;

**WHEREAS** the Moorish American People are a People of deeply-held religious convictions springing from the Holy Scriptures of the Holy Koran of the Moorish Science Temple of America and the Learning, Teachings and Truth of the Holy Prophet Noble Drew Ali. The Holy Prophet Noble Drew Ali led his People back to the Principles and standards of their ancient forefathers' Free National Principles and Standards;

**WHEREAS** the Principles of Love, Truth, Peace, Freedom and Justice inspired concepts of civil government that are contained in our Declaration of Independence and Constitution of the United States of America Republic;

WHEREAS the Moorish American People, are now in great comprehension that, as a Nation of People being Nationwide in scope to achieve peace as well as unity as a single harmonious Nation, there must be uniform Laws for the Nation. The Constitution and Laws of the United States of America Republic are "the Rock on which our Republic rests";

**WHEREAS** the history of our Nation clearly illustrates the value of a Nation to be able to create and pass its own Laws are beneficial to a Society to Enforce the Laws of the Nation. This is not to remove or change **The Moorish American People** from voluntarily applying and extending the learning, teachings and truth of the Holy Koran of the Moorish Science Temple of America in the lives of individuals, families, or in their society as a nation of People:

**WHEREAS** this Nation now faces great challenges that will test this Nation as it has never been tested before; and

WHEREAS that renewing our knowledge of Law, Divine and National and having faith in Our Universal Creator through Holy Scriptures of the Holy Koran of the Moorish Science Temple of America, the Holy Bible and the Great Qu'ran of Mohammed as we honor all the divine Prophets Jesus, Mohammed, Buddha and Confucius. Therefore, the Constitution and Laws of the United States of America Republic and knowledge of the aforementioned Holy Scriptures can only strengthen our nation. I, President Christopher H- Cannon: Bey, therefore establish with the consent of the Continental Congress the provisions as the Laws of the United States of America Republic:

**NOW,** <u>THEREFORE</u>, <u>be</u> it **Resolved** by the Continental Congress of the United States of America Republic in Continental Congress assembled, That the President is authorized and requested to designate the administration of said laws.

## TITLE I – Criminal Code

## Public Law 111-76

#### **CHAPTER65**

#### Treason, Sedition and Subversive Activities

#### Section 2381 - Treason

Whoever, owing allegiance to the United States of America Republic, levies war against them or adheres to their enemies, giving them aid and comfort within the United States of America Republic or elsewhere, is guilty of treason and shall suffer death, or shall be imprisoned not less than five years and fined under this title but not less than \$10,000; and shall be incapable of holding any office under the United States of America Republic.

#### Section 2382 - Misprision of treason

Whoever, owing allegiance to the United States of America Republic and having knowledge of the commission of any treason against them, conceals and does not, as soon as may be, disclose and make known the same to the President or to some judge of the United States of America Republic, or to the governor or to some judge or justice of a particular Province State, is guilty of misprision of treason and shall be fined under this title or imprisoned not more than seven years, or both.

### Section 2383 - Rebellion or insurrection

Whoever incites, sets on foot, assists, or engages in any rebellion or insurrection against the authority of the United States of America Republic or the laws thereof, or gives aid or comfort thereto, shall be fined under this title or imprisoned not more than ten years, or both; and shall be incapable of holding any office under the United States of America Republic.

## Section 2384 - Seditious conspiracy

If two or more <u>persons</u> in any Province State, or in any place subject to the jurisdiction of the United States of America Republic, conspire to overthrow, put down, or to destroy by force the Government of the United States of America Republic, or to levy war against them, or to oppose by force the authority thereof, or by force to prevent, hinder, or delay the execution of any law of the United States of America Republic, or by force to seize, take, or possess any property of the United States of America Republic contrary to the authority thereof, they shall each be fined under this title or imprisoned not more than twenty years, or both.

### Section 2385 - Advocating overthrow of Government

Whoever knowingly or willfully advocates, abets, advises, or teaches the duty, necessity, desirability, or propriety of overthrowing or destroying the government of the United States of America Republic or the government of any Province State, or Possession thereof, or the government of any political subdivision therein, by force or violence, or by the assassination of any officer of any such government; or

Whoever, with intent to cause the overthrow or destruction of any such government, prints, publishes, edits, issues, circulates, sells, distributes, or publicly displays any written or printed matter advocating, advising, or teaching the duty, necessity, desirability, or propriety of overthrowing or destroying any government in the United States of America Republic by force or violence, or attempts to do so; or

Whoever organizes or helps or attempts to organize any society, group, or assembly of persons who teach, advocate, or encourage the overthrow or destruction of any such government by force or violence; or becomes or is a member of, or affiliates with, any such society, group, or assembly of persons, knowing the purposes thereof—

Shall be fined under this title or imprisoned not more than twenty years, or both, and shall be ineligible for employment by the United States of America Republic or any department or agency thereof, for the five years next following his conviction.

If two or more persons conspire to commit any offense named in this section, each shall be fined under this title or imprisoned not more than twenty years, or both, and shall be ineligible for employment by the United States of America Republic or any department or agency thereof, for the five years next following his conviction.

As used in this section, the terms "organizes" and "organize", with respect to any society, group, or assembly of persons, include the recruiting of new members, the forming of new units, and the regrouping or expansion of existing clubs, classes, and other units of such society, group, or assembly of persons.

### Section 2386 - Registration of certain organizations

**(A)** For the purposes of this section:

"Attorney General" means the Attorney General of the United States of America Republic;

"Organization" means any group, club, league, society, committee, association, political party, or combination of individuals, whether incorporated or otherwise, but such term shall not include any corporation, association, community chest, fund, or foundation, organized and operated exclusively for religious, charitable, scientific, literary, or educational purposes;

**"Political activity"** means any activity the purpose or aim of which, or one of the purposes or aims of which, is the control by force or overthrow of the Government of the United States of America Republic or a political subdivision thereof, or any Province State or political subdivision thereof; An organization is engaged in "civilian military activity" if:

- (1) it gives instruction to, or prescribes instruction for, its members in the use of firearms or other weapons or any substitute therefor, or military or naval science; or
- (2) it receives from any other organization or from any individual instruction in military or naval science; or
- (3) it engages in any military or naval maneuvers or activities; or
- (4) it engages, either with or without arms, in drills or parades of a military or naval character; or
- **(5)** it engages in any other form of organized activity which in the opinion of the Attorney General constitutes preparation for military action; An organization is "subject to foreign control" if:
  - (a) it solicits or accepts financial contributions, loans, or support of any kind, directly or indirectly, from, or is affiliated directly or indirectly with, a foreign government or a political subdivision thereof, or an agent, agency, or instrumentality of a foreign government or political subdivision thereof, or a political party in a foreign country, or an international political organization; or
  - **(b)** its policies, or any of them, are determined by or at the suggestion of, or in collaboration with, a foreign government or political subdivision thereof, or an agent, agency, or instrumentality of a foreign government or a political subdivision thereof, or a political party in a foreign country, or an international political organization.

(1) The following organizations shall be required to re

(1) The following organizations shall be required to register with the Attorney General:

Every organization subject to foreign control which engages in political activity;

Every organization which engages both in civilian military activity and in political activity;

Every organization subject to foreign control which engages in civilian military activity; and

Every organization, the purpose or aim of which, or one of the purposes or aims of which, is the establishment, control, conduct, seizure, or overthrow of a government or subdivision thereof by the use of force, violence, military measures, or threats of any one or more of the foregoing.

Every such organization shall register by filing with the Attorney General, on such forms and in such detail as the Attorney General may by rules and regulations prescribe, a registration statement containing the information and documents prescribed in subsection (B)(3) and shall within thirty days after the expiration of each period of six months succeeding the filing of such registration statement, file with the Attorney General, on such forms and in such detail as the Attorney General may by rules and regulations prescribe, a supplemental statement containing such information and documents as may be necessary to make the information and documents previously filed under this section

accurate and current with respect to such preceding six months' period. Every statement required to be filed by this section shall be subscribed, under oath, by all of the officers of the organization.

- (2) This section shall not require registration or the filing of any statement with the Attorney General by:
  - (a) The armed forces of the United States of America Republic; or
  - **(b)** The organized militia or National Guard of any Province State, or possession of the United States of America Republic; or
  - **(c)** Any law-enforcement agency of the United States of America Republic or possession thereof, or of any Province State or political subdivision of a Province State, or of any agency or instrumentality of one or more Province States; or
  - **(d)** Any duly established diplomatic mission or consular office of a foreign government which is so recognized by the United States of America Republic Department of State; or
  - **(e)**Any nationally recognized organization of persons who are veterans of the armed forces of the United States of America Republic, or affiliates of such organizations.
- (3) Every registration statement required to be filed by any organization shall contain the following information and documents:
  - (a) The name and post-office address of the organization in the United States of America Republic, and the names and addresses of all branches, chapters, and affiliates of such organization;
  - **(b)** The name, address, and nationality of each officer, and of each person who performs the functions of an officer, of the organization, and of each branch, chapter, and affiliate of the organization;
  - **(c)** The qualifications for membership in the organization;
  - (d) The existing and proposed aims and purposes of the organization, and all the means by which these aims or purposes are being attained or are to be attained;
  - **(e)** The address or addresses of meeting places of the organization, and of each branch, chapter, or affiliate of the organization, and the times of meetings;

- **(f)** The name and address of each person who has contributed any money, dues, property, or other thing of value to the organization or to any branch, chapter, or affiliate of the organization;
- **(g)** A detailed statement of the assets of the organization, and of each branch, chapter, and affiliate of the organization, the manner in which such assets were acquired, and a detailed statement of the liabilities and income of the organization and of each branch, chapter, and affiliate of the organization;
- **(h)** A detailed description of the activities of the organization, and of each chapter, branch, and affiliate of the organization;
- (i) A description of the uniforms, badges, insignia, or other means of identification prescribed by the organization, and worn or carried by its officers or members, or any of such officers or members;
- **(j)** A copy of each book, pamphlet, leaflet, or other publication or item of written, printed, or graphic matter issued or distributed directly or indirectly by the organization, or by any chapter, branch, or affiliate of the organization, or by any of the members of the organization under its authority or within its knowledge, together with the name of its author or authors and the name and address of the publisher;
- **(k)** A description of all firearms or other weapons owned by the organization, or by any chapter, branch, or affiliate of the organization, identified by the manufacturer's number thereon;
- (1) In case the organization is subject to foreign control, the manner in which it is so subject;
- (m) A copy of the charter, articles of association, constitution, bylaws, rules, regulations, agreements, resolutions, and all other instruments relating the organization. powers. and purposes of the organization and to the powers of the officers of the organization and of each chapter, branch, and affiliate of the organization; and
- (n) Such other information and documents pertinent to the purposes of this section as the Attorney General may from time to time require. All statements filed under this section shall be public records and open to public examination and inspection at all reasonable hours under such rules and regulations as the Attorney General may prescribe.
- **(C)** The Attorney General is authorized at any time to make, amend, and rescind such rules and regulations as may be necessary to carry out this section, including rules and regulations governing the statements required to be filed.

**(D)** Whoever violates any of the provisions of this section shall be fined under this title or imprisoned not more than five years, or both.

Whoever in a statement filed pursuant to this section willfully makes any false statement or willfully omits to state any fact which is required to be stated, or which is necessary to make the statements made not misleading, shall be fined under this title or imprisoned not more than five years, or both.

#### Section 2387 - Activities affecting armed forces generally

- (a) Whoever, with intent to interfere with, impair, or influence the loyalty, morale, or discipline of the military or naval forces of the United States of America Republic:
  - (1) advises, counsels, urges, or in any manner causes or attempts to cause insubordination, disloyalty, mutiny, or refusal of duty by any member of the military or naval forces of the United States of America Republic; or
  - (2) distributes or attempts to distribute any written or printed matter which advises, counsels, or urges insubordination, disloyalty, mutiny, or refusal of duty by any member of the military or naval forces of the United States of America Republic—

Shall be fined under this title or imprisoned not more than ten years, or both, and shall be ineligible for employment by the United States of America Republic or any department or agency thereof, for the five years next following his conviction.

**(b)** For the purposes of this section, the term "military or naval forces of the United States of America Republic" includes the Army of the United States of America Republic, the Navy, Air Force, Marine Corps, Coast Guard, Navy Reserve, Marine Corps Reserve, and Coast Guard Reserve of the United States of America Republic; and, when any merchant vessel is commissioned in the Navy or is in the service of the Army or the Navy, includes the master, officers, and crew of such vessel.

Section 2388 – To be legislated.

# Section 2389 - Recruiting for service against United States of America Republic

Whoever recruits soldiers or sailors within the United States of America Republic, or in any place subject to the jurisdiction thereof, to engage in armed hostility against the same; or

Whoever opens within the United States of America Republic, or in any place subject to the jurisdiction thereof, a recruiting station for the enlistment of such soldiers or sailors to serve in any manner in armed hostility against the United States of America Republic—

Shall be fined under this title or imprisoned not more than five years, or both.

## Section 2390 - Enlistment to serve against United States of America Republic

Whoever enlists or is engaged within the United States of America Republic or in any place subject to the jurisdiction thereof, with intent to serve in armed hostility against the United States of America Republic, shall be fined under this title [1] or imprisoned not more than three years, or both.
